ADDITIONAL INFORMATON

Insurance. For a sidewalk café on any portion of any public sidewalk or public property, the licensee shall secure and maintain comprehensive general liability insurance protection and dram shop insurance (if applicable), including but not limited to coverage for all premises and non-premises operations, independent contractors, broad form property damage coverage, including contractual liability protection covering the indemnification of the Village, its officers, agents and employees by the owner/operator. This insurance shall provide bodily injury limits of not less than \$1,000,000.00 for each occurrence and not less than \$1,000,000.00 in the aggregate, and with property damage limits of not less than \$500,000.00 for each occurrence and not less than \$500,000.00 in the aggregate. Such insurance shall name the Village of Lemont as an additional insured and shall provide that the policy will not terminate or be canceled prior to the expiration date except upon 30 days' advance written notice to the Village.

Placement, Use, and Type of Furniture. Leave at least four feet of unobstructed, accessible route along the sidewalk or other pedestrian way and at least 36 inches of accessible route between tables and chairs. Barriers to demarcate sidewalk café area are required when alcoholic beverages will be served. If barricades are required or used, they shall be of wrought iron or metal construction, chain, or planters. Furniture shall be of wrought iron or metal constructed primarily of plastic shall be used. All furniture shall be firmly secured at the end of each business day. See Village of Lemont Ordinance O-66-11 for more information on placement, use and type of furniture and barriers.

Upkeep. The licensee shall be responsible for the maintenance and upkeep of the public right-of-way used in the operation of a licensed sidewalk café. The licensee shall be responsible for damage to the public right-of-way or public property.
