From the Mayor's Desk



My first full year in office has been an enjoyable and productive experience working alongside the Village Board, staff, stakeholders and residents of Lemont. Our goal remains to provide an environment with the best possible services in the most economical and efficient manner possible in order to grow our property values and increase our business base.

I had the pleasure of sharing a significant amount of information at our March 2018 State of the Village Address. This presentation is accessible on our website at http://lemont.il.us/721/State-of-the-Village-Address, and on our Village of Lemont YouTube page. One of the things I shared was our financial outlook and our current environment of both decreasing revenues along with increasing expenses. As a town with a population of less than 25,000 residents, we are defined by Illinois state law as a "non-home rule community," which means we are extremely reliant on the State of Illinois for a significant portion of general fund revenues and the rules in which are in place for us to manage our Village. Once again this year, the Illinois State Legislature has reduced our state shared revenue allocation, and has yet to provide a path forward on meaningful pension reform or other ways in which we can significantly manage our fixed costs or raise additional revenues. These issues, along with increasing employee pension and healthcare costs, have unfortunately created a deficit of nearly \$1 million in our Lemont general fund. In order to overcome this deficit and balance our budget here in Lemont, the Village Board has made tough decisions including reducing staffing levels, made significant cuts to our road program, and entirely

cut our capital equipment replacement program. While we were able to make these cuts in the short-term, in order to achieve our targets for a balanced budget and adequate fund balances, they are not long-term strategies for financial sustainability.

While we will continue to encounter these headwinds and trends, as a board we recognized these challenges and have already taken steps over the past year to take corrective actions. Relying solely on the State of Illinois for our revenue streams and the rules in which we are able to operate has created an unsustainable situation going forward in our pursuit to maintain a quality community and provide quality services to our residents.

As initial steps to overcome these challenges, we previously introduced our ten-point economic development plan to spur local economic activity and have made great strides in a short period on the plan. From improvements to assist and support our business community and committees, reallocating resources towards economic development, positively promoting Lemont, successful new business recruitments, creating a recreation destination, streamlining processes for commercial and residential construction, and seeking incentives for developers, we continue to see progress with our economic development plan.

The progress on our economic development initiatives will not only produce the amenities our residents desire, but will increase our local revenue sources. Residential growth, building growth and business growth all add to our top line revenues and the benefits of the development can be felt locally. As part of our economic development plan, and with input from local builder groups, we identified opportunities to become more efficient and immediately took steps to reduce the time cycle it takes to build in Lemont. We are also in the process of modernizing our land use and building codes to more closely meet the market demand so we can take advantage of growth and economic development opportunities. We currently have seven developments under construction and four new developments approved so far in 2018. Home sales in our zip code were up 94% last summer from the same period five years earlier, proving that Lemont remains a desirable community and new families continue to regenerate into the community. Last year, new home construction alone yielded 116 new homes which generated a construction value of \$24.4 million, which will create approximately \$1 million in new property taxes for all of our taxing bodies.

There are several other initiatives underway that will produce economic development and additional revenue and amenities for the community. These initiatives include the designation of a new Tax Increment Finance (TIF) District and approval of a transit-oriented development (TOD) in our downtown, improvements to the I&M Canal, an exciting private recreational development in the quarry area, the redevelopment of old Chipain's and the bowling alley site, a new restaurant and businesses uptown, and potential new development opportunities on the east and southern portions of town.

While these new developments are exciting and will bring in new revenues to the community over time, additional measures of raising revenues and/or service cuts will be necessary in order for the Village to continue to operate within its means. The Village Board will be presenting an array of options to overcome these challenges, and we are interested in our residents input on preferences for revenue raising and/or service cuts, along with other community problems that may need to be addressed by the Village. Cook County State's Attorney Update

As you may recall, in the summer of 2016 the Cook County State's Attorney filed a lawsuit against the Village of Lemont seeking the removal of certain territory (17 properties) from the Village and placed into Cook County's jurisdiction. The State's Attorney's complaint includes several properties along Bell Road and residential properties in the Glens of Connemara, Kettering Estates, Enclave at Kettering, Red Drive properties and adjacent incorporated properties. The earliest annexation being

challenged by the State's Attorney dates back over 22 years ago, and the most recent property being challenged is over 8 years old. The State's Attorney's lawsuit followed a nearly identical lawsuit that was first filed by the Village of Palos Park in February of 2016, in which Lemont had prevailed.

To say the least, as a board we are perplexed by the State's Attorney's involvement in this case. The property owners and the Village acted and cooperated in good faith to develop within the Village of Lemont's jurisdiction and to be part of the Lemont community. Today, and over the last couple of decades, the Village has provided utilities, police services, public works services and zoning/code enforcement control over these areas. These areas consist of a church, properties owned by our two school districts including an athletic complex, a Lemont Fire Station and over 250 homes and 800+ residents. These properties being under the jurisdiction of the Village of Lemont provide a benefit to the homeowners and property owners and take away from no one else. In fact, removing these properties from the Village of Lemont will only increase the burden placed on Cook County and is contrary to Cook County's plans to remove unincorporated territory from its service obligations. The result of the State's Attorney's actions will serve no public good, and will only frustrate these residents and property owners along with the Village.

It is extremely rare for the State's Attorney to get involved in matters of local concern, and as a Village we have been attempting to better understand the concerns and motivations of the State's Attorney's office. We continue to pursue correspondence, but have been unable to secure a meeting with the ultimate decision makers in this case or receive feedback on their reasoning in this action. The Village has been actively defending the case since it was filed and will continue to do so to protect these properties from this unprecedented attack.

While we have heard from residents across the community wanting to get involved in this case, we have focused on involving and communicating with the residents and property owners most affected by the lawsuit first. Please stay tuned to our communication channels for updates on this case and information on how you can get involved.

The Village Board and I look forward to continuing to serve the great people of Lemont. Be sure to patronize our local businesses and please plan to attend the many activities planned throughout the town this summer. Enjoy and have a safe and active summer!

SEASONAL REMINDERS



BOAT, CAMPER, TRAILER STORAGE / PARKING

Village ordinance requires that boats, campers or trailers may only be stored/parked at a residence if located in a garage or other fully enclosed structure that substantially conceals them from public view. A boat, camper, or trailer may be parked at a residence for the purpose of loading or unloading for no more than 8 consecutive hours or 12 hours in a 24-hour period.

Non-compliance may result in fines. Any questions regarding the ordinance should be addressed to the Village Code Enforcement Officer at (630) 243-2704.

ODD-EVEN WATERING REGULATIONS IN EFFECT

Properties with an odd number address may water on odd-numbered calendar days. Properties with an even numbered address may water on even numbered calendar days. Furthermore, no lawn sprinkling is allowed from the Village water system between the hours of 10 a.m. - 6 p.m. Odd-even regulations apply until October 1. On the day new sod is laid, residents may water freely (no permit required). Thereafter, the odd-even regulations apply.

SWIMMING POOLS

Swimming pools 24" and higher require a building permit and a 5' protective barrier. Call (630) 257-1580 for more information.

LAWN SPRINKLER AND COMMERCIAL RPZ VALVE CERTIFICATION

The Village of Lemont has contracted with Backflow Solutions, Inc. (BSI) to administer our cross-connection control/backflow tracking program. The Village will be utilizing BSI Online for all test report submittals.

All annual backflow assembly test reports must be

submitted electronically via the BSI Online system at www.bsionlinetracking.com by the testing company. Please note there is a filing fee of \$12.95 per test report submitted.

Each resident who owns a backflow assembly (RPZ valve) will be sent a notification letter from BSI with a Customer Confirmation Number (CCN). This number must be given to the tester in order for the reports to be properly filed with BSI.

For any questions regarding this program, please contact BSI via e-mail (bsionline@backflow.com) or phone (800) 414-4990.

Any residents wishing to permanently disconnect their lawn sprinkling system must contact the Village of Lemont Building Department at (630) 257-1580.

MOSQUITO ABATEMENT

The Public Works Department manages the Village's mosquito abatement program. Residential spraying will be limited only to periods of excessive annoyance and storm drains will be treated regularly. Advance notice before spraying will be given upon request: (630) 257-2532. Sign up to receive notification via "Stay Informed" — Public Works Notifications.

HOW CAN YOU HELP?

- Promptly remove standing water from all pots, containers, and tire swings around the yard. Mosquitoes can develop in only five days.
- Keep weeds and grass mowed.
- Keep gutters free of leaves and debris so water runs freely.
- Change the water in bird baths once a week.
- Clean and chlorinate swimming pools, outdoor saunas, and hot tubs regularly.
- Drain water from pool covers.



2017 WATER QUALITY REPORT

Our 2017 Water Quality Report in Lemont has met all the USEPA drinking water requirements and standards. Each year, the Village of Lemont provides its customers with an Annual Water Quality Report to let them know how our water quality stacks up against established Federal and State drinking water standards. We encourage you to review this report, as it provides details about the source and quality of the drinking water delivered to our community in 2017.

ANNUAL WATER RATE INCREASE EFFECTIVE OCTOBER 1, 2018

Beginning October 1, a slight increase in the water rates will become effective. The rate for the first 4,000 gallons will increase from \$36.39 to \$37.48, and each additional thousand gallons will increase from \$6.68 per 1,000 gallons to \$6.81 per thousand. Residential sewer rates will increase from \$25 to \$30.

For Senior rates, the first 4,000 gallons will increase from \$18.20 to \$18.75, and each additional thousand gallons will increase from \$3.34 per 1,000 gallons to \$3.41 per thousand. Senior sewer rates will remain unchanged.

These annual incremental increases are necessary to keep up with the costs to maintain and improve the Village's water system.

Frequently Asked Questions

The Village Board and staff receive many questions from our residents. We would like to share the most frequent questions with all of our residents in our new "Frequently Asked Questions" section of our newsletter. We will also keep a running log of these questions on our website in the "Village Hall" section.

1. Why can't the Village secure signs along the tollway pointing out businesses and other Lemont attractions?

Answer: As a matter of policy, the tollway does not allow signs directing to specific businesses, similar to ones you see on other interstate highways. The tollway does have an application process for signs that could point out attractions such as Downtown Lemont or other general landmarks. The tollway has criteria that governs these signs including number of visitors to a site, etc. The Village is in the process of applying for a sign of this nature.

2. I'm hearing talk of some homes in Lemont wanting to become Airbnb's. Is this allowed?

Answer: Being a "non-home rule community" (population under 25,000), the Village is limited in its ability to regulate rentals of any kind within our borders. As a result, under Illinois state law the Village does not have the authority to regulate or license these short-term rentals, therefore we cannot allow or prohibit Airbnb's. The Village will be looking into other ways in which it can regulate these types of uses via its zoning code in the coming months.

3. With the talk of tight budget constraints and potential staff reductions, can raising our taxes alleviate some of this burden to the Village?

Answer: Being a "non-home rule community," the Village's revenue raising abilities are limited to what the State legislature specifically allows. Since the Village has implemented most of the revenue streams allowable per state statute for a non-home rule community, it may have no choice but to cut staff and reduce service levels in order to operate in a fiscally responsible manner.

4. Why does the Village require vehicle stickers when other towns have been able to eliminate them?

Answer: The Village recognizes the inconvenience and hardship associated with purchasing a vehicle sticker. However, for a non-home rule community the vehicle sticker is one of the few revenue streams specifically allowed by state statute for a non-home rule entity to implement. Other towns that have eliminated the sticker have likely replaced the revenue stream with more palatable revenue streams which the Village is not able to implement.

5. There seems to be an increase in the amount of truck traffic and parking areas for semi-trucks in the town. Can't something be done to alleviate this?

Answer: Again, due to "non-home rule community" rules we must abide by via the State of Illinois, the Village is limited in its ability to regulate trucking operations and/or truck routes. Through zoning and annexation agreements, the Village can limit new businesses, but existing businesses and ones that develop outside Lemont and in the unincorporated areas, the Village may have limited options to regulate at this time.

6. If "Home-Rule" communities have a better ability to govern their towns, how can Lemont become a "Home-Rule" town? Answer: There are only two ways a town can become "Home-Rule" and that is by either having a population of over 25,000 or by passing a referendum that requires a community consensus.

7. Why aren't there more Metra train stops and pickups in town, along with a weekend schedule?

Answer: The Village has worked with its partners along the Heritage Corridor line for several years with a goal of increasing service and ridership on the line. There are several reasons Metra has given over the years for the lack of service on the Heritage Corridor line. The majority of the reasons involve ownership of the line and improvements required to accommodate more traffic. Metra operates the Heritage Corridor line through a trackage rights agreement with Canadian National (CN) Railway. Due to heavy levels of freight traffic on the line and only two tracks along the line, CN has been unwilling to allow significantly more commuter service unless additional infrastructure is added to accommodate the increased service. In 2017, the Village and its partners were able to achieve a mid-day outbound train to be added to the schedule. Until significant improvements are made to the line, there are no plans currently for additional train service. A stop was added to the Heritage Corridor line earlier this year in the Village of Romeoville. This stop has already produced enhanced ridership which may give assist in our lines case for more service.

8. Why do trains have to blow their horns through the entire town? Can't they make this quieter or sound them less often?

Answer: In order to achieve "quiet zone" status as governed by the Federal Railroad Administration (FRA), the crossings through a town have to meet certain criteria for safety to make up for the loss of the horn sound when a train passes through. Lemont has five public crossings and several other private crossings of which significant safety improvements are required for the majority of the crossings to meet federal rules on "quiet zones." The estimated price tag for the improvements is \$1.25 million according to a recent study completed by the Village in 2015. To add another variable in the issue, a crossing is being proposed at Walker Road for a private development adjacent to the quarry area. The Village will update the study and present new numbers for consideration once this crossing is being implemented.

AT YOUR DOOR SPECIAL COLLECTION SERVICE

As a reminder, Village of Lemont, through Waste Management, has implemented the At Your Door Special Collection service. This service was implemented as a solution to the ever-increasing inquiries from residents about where to dispose of recyclable and hazardous waste items. A resident survey resulted in an overwhelming acceptance of such a program. The At Your Door Service is available to single and multi-family homes that are covered under our current Waste Management agreement. The monthly fee of \$1.25 is on residents quarterly Waste Management invoice; this is not an opt-out service.

Through this program, you can schedule a collection of these materials right from your home. Acceptable materials for pickup include:

- Automotive Products (used motor oil, oil filters and batteries)
- Garden Chemicals (pesticides, herbicides, weed killers, etc.)
- Paint Products
- Household Cleaners
- Swimming Pool Chemicals
- Electronics (TV's, computers, monitors and more)
- Household Batteries
- Fluorescent tubes and Compact Fluorescent Lamps (CFL)
- Thermometers and thermostats

POLCO – A COMMUNICATION POLL / SURVEY SYSTEM

It is important to citizens to have their voices heard, and it's important for our municipality to hear your voices. The Village of Lemont will soon be implementing a communication poll / survey program to inform residents of various topics, and receive input back from residents on these topics. Through POLCO, a survey-type communication system, we can share information on decisions the Village is considering, and get feedback from citizens so you have a say in where things are headed. Citizens are invited to set up a free, private account so when we need input or ideas, our questions show up in your POLCO feed for you to respond to. More information will follow in the coming months.

Animal Control

As a reminder to our residents, following are Village Code of Ordinances regarding animal control:

6.04.020 - Definitions.

Control of a dog, cat or pet means that the dog, cat or pet is:

- 1. On a leash not more than eight feet in length;
- 2. Within a private vehicle being driven or parked;
- 3. On or in the property of their owner.

6.04.110 - Traffic Accidents.

a. Any person who, as the operator of a motor vehicle, strikes a domestic or wild animal, shall stop at once and render such assistance as may be possible, and shall immediately report such injury to the animal owner, if known, or to the appropriate law enforcement agency, or to the local humane society.

6.04.200. - Excrement restrictions.

- No person shall allow cat or dog excreta to accumulate in any yard, pen
 or premises in or upon which a cat or dog shall be confined or kept so
 that it becomes offensive to those residing in the vicinity.
- b. No owner shall fail to remove excrement deposited by his cat or dog, except guide dogs, upon the public ways or within the public places of the village, or upon the premises of any person other than the owner without that person's consent.

6.04.220 - Unlawful acts by animals.

- a. No person shall permit his cat, dog or pet to:
 - 1. Run uncontrolled.
 - 2. Molest persons or vehicles by chasing, barking or biting.
 - 3. Attack other animals.
 - 4. Damage property other than their owner's.
 - 5. Bark, whine, howl or make excess noises so as to cause a nuisance.

ECONOMIC DEVELOPMENT | NEW BUSINESSES IN TOWN



DOWNTOWN

Hughie's Irish Pub | 118 Stephen Street

This building was most recently the southern half of H&H Family Restaurant. Over the past 50 years, among other things, this location was a house, a drug store, a jewelry store, a meat market, and early on it was the site of the post office.

It sits on the piece of land that is the first plat of Lemont, made as early as 1850, that indicates this portion of town was called "Keepataw" in honor of an Indian Chief who formerly lived in the area.



Wooden Paddle | 212 Stephen Street

Over the past 125 years, this building at the northwest corner of Illinois Street and Stephen Street served as various stores, offices, restaurants, bars and a saloon. Many of you may remember it as Little Sweden, RPM's or Norb's Place.

Today, Wooden Paddle serves a unique variety of tasty pizza cooked in a wood-fired oven. They also do catering for events.



UPTOWN

Fork & Spoon Cafe | 1264 State Street

This location served as the town's primary breakfast place for 12 1/2 years.

Originally known as Pancake Cafe, the restaurant closed in 2013.

Now, five years later, we are excited to have the doors open again as Fork & Spoon serves up Greek-style breakfast and lunch.



Market on State Coming in Spring of 2019 | 1100 State Street

Built in 1962, for 55 years this location served as the primary grocery store in town.

It was the site of Pick N Save Supermarket, Kroger, Ordman's Park & Shop and Chipain's Finer Foods.

An interesting fact is that the first Ordman Brother's grocery store opened in downtown Lemont in 1919. Through two generations, the Ordman's served the residents of Lemont for 67 years.



Quarry Pub & Grill | 1015 State Street

Over a period of 62 years, this location served as a bowling alley and restaurant.

As history has it, there was not much in the way of entertainment in Lemont in the 1940's, so a group of Lemont businessmen, which included the Ordman brothers, formed a corporation and built the Lemont Bowling Lanes which opened in 1950.

After being closed for six long years, we welcome Quarry Pub & Grill into town. They will reopen the bowling lanes as part of their Phase 2 project later in the year.




Historic Downtown Lemont
