From the Mayor's Desk

Over the past few months, much of our focus was aimed at objecting to the Intergovernmental Agreement between the Village of Palos Park and the Cook County Forest Preserve District, which would allow Palos Park to annex certain Forest Preserve property located in unincorporated Lemont. The annexation of district property would provide Palos Park with the opportunity to annex properties in Lemont Township including Cog Hill, Glen Eagles Golf Club, Mid-Iron Golf Club and Ludwig Farm.



The community worked diligently to stress the importance of local control and asked the Forest Preserve Board not to involve itself in land matters between municipalities. In spite of all of our efforts, the Forest Preserve Board (which are the same members as the Cook County Board of Commissioners) voted in favor of this annexation.

On behalf of the Village Board of Trustees, I want to thank the residents and community leaders for all of your calls, letters, and emails to the Cook County Commissioners and the showing of support throughout the process. Although we are extremely disappointed with the outcome, our opinion on the matter has not changed. The properties in question, when they are ready to develop, should be developed within the Village of Lemont and be subject to the same level of oversight and review from our community that all development proposals receive. The Board and I will explore all options available to us, and will continue to fight for local control with regard to these properties and others where development will impact our residents, businesses and infrastructure.

Another key issue that we will continue to monitor is the unresolved state budget issue and its impact on Lemont. Although we are still receiving our local distributive funds at this time, the State is withholding our motor fuel tax (MFT), video gaming tax and local use tax. Legislation is being proposed to ensure local government receives the revenues owed,

however, there is no final word on the overall budget. The total withheld funds amount to approximately \$80,000 per month and affects our general operating fund and road maintenance funds. Conservative budgeting and a strong financial condition allow the Village to operate seamlessly in the short-term. However, further delays or cuts in our revenues will have significant impacts on our ability to continue the provision of quality services for our residents and businesses.

In the spirt of the holiday season, many activities will take place in December including our Hometown Holiday. This year many of our downtown businesses will be open and involved in the festivities which will include a Kris Kringle Market, so be sure to join us on Saturday, December 5, from 4-10 p.m. Remember to shop local for your holiday gift giving and keep your dollars in our town; we have many unique stores and great restaurants. Collection and Disposal Agreement Requirements of all Applicable Properties

In April of 2014, the Village entered into an eight-year agreement with Waste Management of Illinois. This agreement allows Waste Management exclusive rights to collect and dispose of wastes, recyclables and landscaping materials for all applicable properties within the Village limits. These applicable properties include all single-family, townhouse and duplex residential dwellings and all multi-family residential of up to four units. As a reminder to residents residing in the applicable properties, in order to protect the public health and welfare and the quality of the environment, you are required to use Waste Management services and will be billed by Waste Management accordingly. Trustee Stapleton Receives 2015 Senior Citzen of the Year Award



Village of Lemont Trustee Ron Stapleton received the 2015 Senior Citizen of the Year Award on November 2, 2015, from Congressman Dan Lipinski. Since moving to Lemont in 1989 from Chicago, Ron had a desire to become involved in the Village, and in 1992 he became a volunteer member of Downtown Lemont Incorporated. He served on the Design Committee, became a member of its board in 1994, and in 1998, became the board president.

In 1995 Ron was appointed to the Planning & Zoning Commission where he served as a volunteer for six years. He was then appointed to the Lemont Zoning Board of Appeals for two years. In 2003, Ron was elected as a Trustee on the Lemont Village Board, where he is currently serving his fourth term.

Throughout this time, Ron volunteered on several committees and charitable organizations, and is still active in many. He is also the current liaison to the Art & Culture Commission, Planning & Zoning Commission, and the Historic Preservation Commission. He can be seen at many events, fundraisers, and ribbon cutting ceremonies around town, and is always willing to help out where needed.

Emerald Ash Borer Update



The mass removal of the affected Emerald Ash Borer trees has now been completed, and the Village will continue to monitor those deemed 50% or more affected. The removal will continue as necessary, with the next scheduled removal expected to occur between November and January. The Village will begin replacing parkway trees when funding is available, but this process will take several years to complete.

If a homeowner wishes, they can purchase and plant a new parkway tree at their own expense in the parkway adjacent to their home. No permit is required, however, the tree should be an approved parkway tree species, and trees should be planted in accordance with the Village parkway tree planting specifications. The approved parkway tree species list and parkway tree planting specifications are located on our website at www.lemont.il.us/ EmeraldAshBorer. Landscape Waste Collection Ends The First Full Week in December

All landscape waste, including brush and other branches will be collected once per week on the same day as the regular refuse and recycling collection from April 1 through the first full week of December each year. Landscape waste materials should adhere to the following requirements:

- place in biodegradable paper "kraft" type bags, up to 33 gallons in capacity,
- shrubbery cuttings, tree branches, twigs, must be placed either in a kraft paper bag OR in a securely tied bundle,
- ties must be made of string or twine,
- branch bundles must not exceed 4 feet in length, and
- bags containing landscape waste and/or branch bundles cannot exceed 50 pounds in weight.

Residents may rent a 96-gallon cart for \$4/month or purchase one for \$105 based on availability. Carts purchased for the disposal of yard waste must be clearly identified by the resident for the disposal of yard waste.



Electric Aggregation

The Village of Lemont's municipal aggregation plan supplier is currently Homefield Energy. Our 3-year contract term with Homefield Energy began in October of 2014 and expires in October of 2017. Rates are as follows:

- Time Period of October 2014 to October 2016 \$0.06996 per Kwh
- Time Period of October 2016 to October 2017 \$0.06850 per Kwh

Residents are able to join the plan at any time during our contract term with no fee. Residents should always contact their current energy supplier before considering a switch to find out if the current company imposes an early termination fee. It is important to know that through this term, Homefield Energy will not impose a fee for early cancellation. Downtown Parking:

On-street parking time limits in certain downtown areas have been increased from 2-hour to 4-hour parking. The 4-hour parking is effective from 8:00 a.m. – 6:00 p.m., Monday – Saturday, except on holidays at the following locations:

- Talcott Avenue, north side, within designated parking stalls only
- Lemont Street, from Illinois Street to I&M Canal
- Front Street
- River Road, with the exception of designated areas
- Stephen Street, from Illinois Street to River Street
- Canal Street
- Main Street, from Stephen Street to Fremont Street

Other parking restrictions have been modified throughout the downtown, so please pay special attention to the signs noting the restrictions when parking.

Emergencies During A Winter Storm

If an emergency arises during a winter storm, residents should dial 911. All Public Works plowing vehicles maintain continuous two-way radio communication with the Police Department. Snow removal equipment can provide immediate support to ambulance and fire equipment.

Damaged Property

Mailboxes in the Village right-of-way are sometimes damaged during snow removal. These will be replaced with a standard rural route mailbox in the spring. To report damage, call the Public Works Department at (630) 257-2532.

Winter Parking Reminder

During and after any snowfall, please try to remove vehicles from Village streets if at all possible to facilitate clearing. If removing vehicles is not possible,

AFTER a snowfall of 2 inches or more, please park on the ODD-numbered side of the street on odd calendar days, EVEN-numbered side of the street on even calendar days.

The day is considered to begin at 9:00 a.m.

The Public Works Department begins ice and snow control measures even before hazardous road conditions are expected. As soon as conditions warrant it, the salting process begins on major streets designated as primary routes, hills, curves, and all intersections. Residential streets that are relatively flat will be salted only at intersections. Salt remains the most cost effective means of breaking the bond between ice and the street, especially with Lemont's unique topography.

Plowing commences after snow accumulates to an inch or more. Village roadways are divided into 9 zones for the plowing process with primary routes, including hills and school bus routes, being plowed first. As soon as primary routes are cleared, crews will move on to the secondary routes. After all streets are open, trucks will begin the curbing operation.

The goal of the Public Works Department is to remove snow from all streets within six hours after the conclusion of a significant snowfall. Your cooperation in removing vehicles from the street and observing the odd-even parking regulations will make this job easier and more efficient.

Select "Your Voter Information" from the left sidebar, and then select "Register to Vote" from the sidebar; a list of registration options will be shown. The process is simple, and when you complete your registration you will receive an email confirmation of your registration application. You will also receive an email confirmation once the Cook County Clerk's Office received your data. Your Voters Registration card will be mailed to your home.
