From the Mayor's Desk



Preliminary Census Data

According to the recently published census data for Illinois, Lemont's population has grown about 22% since the 2000 census. However, the figure of 16,000 reported for Lemont is about 625 residents fewer than certified in the 2008 special census. If this population is correct, the Village stands to lose about \$75,000 annually in state-shared revenue and motor fuel tax money. The data also shows that there are 380 vacant housing units in Lemont which seems incredibly high, but when the census was taken on April 1, 2010, most of the newly constructed developments in the downtown area were unoccupied so that could very likely account for it.

Public Education in Lemont

Over the past two decades Lemont has grown from a town of 5,640 in 1980 to a thriving community of about 16,000 residents in 2011. In making the decision to move to a growing community like Lemont, one of the biggest considerations is quality of life including excellent schools, parks, and public services. Lemont has been that community for a long time.

A topic of great concern to me personally is the possibility of a state takeover of School District 113A. Local government is designed to have local people make decisions on local issues – when the state takes over, we lose that option. As Mayor, my concern is that the citizens of Lemont get the correct information on this possibility.

An Intergovernmental Meeting was held at the Village Hall on February 24. Each governmental agency, including School District 113A, was given the opportunity to make a presentation to the citizens of Lemont on current issues affecting them. The meeting was carried live on the cable access channels and is being re-broadcast on Comcast Channel 6 and AT&T U-verse Channel 99. Please tune in to gain an awareness of the decisions facing your elected officials.

Mayor's Message (cont'd)

On March 16, a Town Hall Meeting on Public Education in Lemont will be held at Lemont High School. Each school district will give an in depth report on the cost of Public Education and how your education tax dollars are being spent in Lemont. I would urge all citizens to either attend the meeting or view the broadcast to become educated voters on April 5.

Downtown TIF District

In preparation for the sunset of the original Downtown TIF (Tax Increment Finance) District in 2015, the Village is in the process of revising the Redevelopment Plan and Project originally adopted in 1991 to conform to the legislative and local changes that have taken place over the last 20 years. The process is almost as complicated as starting a new TIF, with multiple public meetings and hearings on the amended plan. The first revision to the plan has been prepared and is available for review at the Village Hall by contacting the Clerk's Office. A final public hearing will be held on April 11 at the Village hall on the final revised redevelopment plan. More information is available on page 7.

Grant Funding Awarded

Lemont was one of 18 municipalities in suburban Cook County to receive grant funding from the Cook County Department of Public Health Model Communities grant program. Lemont Park District was a co-applicant for the grant which will provide \$48,000 to examine ways to improve walking and cycling to help make healthier transportation choices easier for individuals and families in Lemont.

Budget & Finance

March is typically the month that the Village Board determines its budget and spending priorities for capital projects for the coming fiscal year. At this point, the state is behind in tax payments to the Village to the tune of \$500,000. This represents our share of the income taxes that the state collects on our behalf and is simply not paying to us. No percentage of the new state income tax increase will be shared with municipalities either. Budget planning becomes nearly impossible with this kind of irresponsible fiscal practice in Springfield. The Village Board will have a struggle assigning priorities and choosing only limited projects within those priorities, but we will do our best to continue providing the level of services we currently provide to the citizens of Lemont.

Finally, I would like to say a word of thanks to the Public Works and Police Departments for their outstanding response to the blizzard this community experienced in February. The Village Board and I are justifiably proud of them and the excellent job they do.

Together we have built the great community that is Lemont. The task ahead of all of us is to maintain the level of excellence we have achieved and continue to work together for the common good.

**2002
Comprehensive
Plan to be Updated**

The Village last updated its comprehensive plan in 2002. Since then, much change has occurred: the downtown redevelopment, the opening of I-355, the construction of new public facilities, the annexation of hundreds of acres, and the construction of numerous subdivisions and new homes. The Village will begin its update of the 2002 plan this year.

Comprehensive plans are made and updated with the involvement of residents and stake holders in the community, and the citizens of Lemont are encouraged to follow and participate in the update. The Planning & Zoning Commission will hold a series of public hearings to collect citizen input.

The first hearing will be **March 16th at 6:30 p.m. at the Village Hall**. Village staff will present an overview of comprehensive planning and an initial outline for the update. Following the staff presentation, the Commission will discuss and take public comment on economic development within the community, e.g., business retention, attracting new businesses, tourism and visitor initiatives, and downtown development.

A subsequent hearing will be held on **April 20** to discuss topics related to transportation and bicycle planning. Topics such as growth management, land use, housing, historic preservation, environment, storm water management, and infrastructure will be discussed at meetings later in the year.

Election Signs may not exceed 16 square feet, must be located on private property (no parkways), and may be installed 30 days before the election. Signs must be removed within 5 days after election.



Work on Water Treatment Systems to Begin

The water treatment systems at both the State Street and Houston Street wells will receive an overhaul next fall. The existing softeners and auxiliary equipment were purchased used from another municipality over 25 years ago and probably have 40 - 50 years of total use on them.

The Public Works Department is taking a proactive approach to protection and delivery of safe drinking water to the residents of Lemont.

Early in 2011, bonds were issued to finance the treatment system replacement and other system-wide improvements.

The village currently uses an ion exchange method to remove naturally occurring radium and other contaminants from the drinking water supply. Advances in technology and equipment will allow the Village to provide improved results more efficiently.

The overhaul will take about 10 months at an estimated cost of \$1,700,000. Once completed, the new treatment equipment should service the community for an additional 25 or more years.

The Houston Street water tower will be cleaned inside and out and repainted in April and May of this year.

Public Works

Water Mains to be Replaced:

Houston Street, Cherokee Place, Kim & Kip Place and New Avenue

This spring, several water mains will be replaced in neighborhoods that have experienced recurring main breaks and water issues over the past several years.

New 8" water main will be constructed on Cherokee Place, Kim Place and Kip Place and a part of Keepataw Drive. As soon as weather permits in April, this project will begin and will include new water connections to residential dwellings.

New 8" and 12" water main will also be constructed on Houston Street between Schultz Street and McCarthy Road beginning this spring.

This summer the 4" water main on New Avenue from Timberline Drive to Lockport Street will be replaced with a 12" main.

Grant Funds Received For Warner Avenue Sewer Separation

Thanks to our legislators, funding in the amount of \$450,000 channelled through the State of Illinois has been received to complete the sewer separation in the Warner/Norton/Eureka area,

Water main was replaced last fall and a temporary surface was applied to the roadway over the winter. Work will resume as soon as weather permits to complete the sewers and do a full resurfacing of the street.

Building Permits Required for Home Improvement Projects

Considering a home improvement project? Most building projects including sheds, fences, pools, and decks require a building permit to ensure compliance with building codes and zoning regulations. Lawn Sprinkler Valves Annual Testing Required

Lawn sprinkler RPZ valves must be tested annually by a certified RPZ valve tester to prevent cross contamination of the public water supply. Annual notices are mailed from the Building Department. A list of certified testers is on the website.

Vacant Property Registry

Residents are asked to report vacant buildings in their neighborhood to the Building Department at 630-257-1580. In order to prevent vandalism and monitor the buildings for broken pipes, electrical issues, etc. the Building Department needs to be aware of these properties.
