From the Mayor's Desk

From our families to yours,

As the end of 2011 approaches, it is a good opportunity to pause and reflect on the past year and look forward into 2012. The Village of Lemont still operates under many of the same financial constraints as in previous years due to a sluggish regional economy and uncertainty with the State of Illinois. Although spared as of now, the threat of reduced revenue sharing from the state to the Village continues to loom. With the Village relying on state shared



tax income for approximately 25% of its general fund budget, this becomes a very important topic for the Board to monitor. Fiscal responsibility will continue to be the Board's number one priority during these times of uncertainty.

Infrastructure Projects in 2011

Even during these difficult economic times, the Village was able to move forward with various successful needed projects. Earlier in the year, the Village Board approved the sale of bonds to finance improvements to the Village's water and sewer system, taking advantage of the low interest rates through Build America Bonds. As construction finishes in 2011, the Village will have a completely updated, safe and secure water supply that will be able to satisfy its current needs while allowing for the growth the Village will see in the future. In addition, the Village has continued its aggressive resurfacing program of local streets, as well as other needed infrastructure improvements. Looking forward to 2012, the Village Board will continue its resurfacing program and to upgrade its infrastructure, specifically planning for and initial work for the needed improvements to Illinois Street, slated to be completed in 2013. In addition, the Village will continue to work with the State of Illinois on the needed improvements to the Walker/McCarthy/Derby triangle intersection, which will begin in the spring, and Walker and McCarthy intersection improvements and signalization that is tentatively planned to begin in the summer or fall next year.

From the Mayor's Desk

Building Activity in 2011

Although still slowed by difficult economic times in the region, the Village has seen permitting activity in 2011 for 25 new single family homes and over 700 total permits for new construction, residential and commercial. Although still well below the boom time levels of 2001-2005, the recent activity in Lemont shows that people are still looking to relocate, reinvest and conduct business in Lemont. Looking forward to 2012, the Village is starting to hear rumblings of additional activity. I hope to be able to present some of these success stories at my Annual State of the Village Address in March.

Electric Aggregation

In 2010, the Illinois State Legislature gave villages a tool to help taxpayers save money. The State has given villages the ability to seek competitive pricing for the provision of electricity to residents and small businesses. In order to seek competitive prices for electrical services in one contract, the Village needs approval from residents through a referendum. The Village Board will be placing the needed referendum on the March 20, 2012 ballot, asking our citizens if the Village should have the authority to seek competitive pricing bids for electrical services under a single contract that would include residents and small businesses. It is hoped that by combining electrical service for all individual customers into a single bid, consumers will have lower electric bills and save money. The Village is also exploring the option of working with other municipalities through the Will County Governmental League, to allow for much greater buying power driving the cost down even more. Electronics Recycling Program

Beginning January 1, 2012, TV's, computers, laptops, monitors, printers, computer peripherals, VCR's, DVD players, gaming systems and other electronic items will be banned from Illinois landfills. Landfilled electronic products contain toxic materials that pose a risk to human health and the environment.

The Village's Public Works Department, 16680 New Ave., will be accepting electronics for recycling during business hours, 7:30 a.m. -4:00 p.m. Monday through Friday. Residents are advised to call ahead before dropping off recycling at 630-257-2532. Computers and computer equipment, including printers, fax equipment, scanners, notebooks, laptops, home sound equipment, calculators, phones, VCR's, microwave ovens, TV's and computer monitors are accepted free of charge. The program is offered in conjunction with COM2 Recycling Solutions.

- Do you know whether or not at least one window in each of the existing sleeping rooms complies with the 2006 International Residential Code as adopted by the Village of Lemont for emergency escape and rescue?
- Do you know if any of your current windows are located in hazardous locations that may require tempered glass?
- Does the window or door that you're looking to purchase comply with the performance requirements of the State of Illinois Energy Code?

Electric Aggregation: Frequently Asked Questions

Q: What is Deregulation?

A: On December 16, 1997, the State of Illinois implemented a plan to deregulate Commonwealth Edison ("ComEd"). Under this plan, ComEd no longer generates electricity for its customers but continues to provide power generated by others through its distribution system. Deregulation means that power can be purchased through any of the 23 Illinois Commerce Commission approved power suppliers.



Q: What is Electric Aggregation?

A: Electric Aggregation is a program that allows local governments to bundle - or aggregate - residential and small commercial retail electric accounts and seek bids for a cheaper source of power. Currently, ComEd customers receive electricity at a price set each year by the Illinois Power Agency, a governmental body that secures electricity on the wholesale market on behalf of ComEd. By bundling residential and small commercial accounts, municipalities can go out into the open market to seek a lower rate for electric power. Since 1999, large industrial and commercial customers have used this option to reduce electricity costs.

Q: How does the program work?

A: Under state law, the municipality must place a referendum on the ballot to ask voters to give the municipal government the authority to aggregate electric accounts and seek bids for power generation. Once voters have approved the referendum on the March 20, 2012 ballot, the municipality will hold at least two public hearings to discuss and create an aggregation plan. Once the plan is in place, municipal staff, with the assistance of energy experts, would prepare and publicize a request for proposals. Only energy suppliers certified and regulated by the Illinois Commerce Commission could respond. The bid that comes closest to achieving the goals of the aggregation plan would be accepted. However, if none of the bids meet the plan's goals, there is no obligation to accept one, and the aggregated accounts will continue to receive power from ComEd at the prevailing rates. A resident or small business has no obligation to participate and could choose to opt-out of the program altogether.

Q: What is the Referendum on the March 20, 2012 Election Ballot?

A: Voters will be asked whether or not our municipality should have the authority to arrange for the supply of electricity for its residential and small commercial retail customers who have not opted out of such a program.

Q: What are the benefits of aggregation?

A: The most important benefit is the opportunity for residents and small businesses to save money on electric supply costs.

Q: Am I obligated to participate?

A: No. Any account holder may opt-out of the program and remain on ComEd's supply service rate. The opportunity to opt-out will be available up to the time of program implementation. Customers will receive notice information of the opt-out period, who to contact, and how they must communicate their intention to opt-out.

Q: What is ComEd's role in this program?

A: ComEd distributes electricity, but does not generate it. As the local electricity distributor, ComEd is responsible for infrastructure, like power lines that bring electricity into homes and businesses, responding to outages and billing. ComEd will continue to bill customers for electric usage regardless of the supplier of that electricity. ComEd, by law, will still be paid to distribute the power to the homes and businesses and handle any emergency repairs.

Q: If I participate, will I get two bills - one from ComEd for delivering the power and another from a company that provides it?

A: No. ComEd will remain responsible for billing customers for all electricity, regardless of the electric supplier. The only change would be the name of the electricity provider on the bill's electricity supply.

Q: I am currently enrolled in ComEd's budget program where you are able to spread out your ComEd electric service costs evenly throughout the year. Will the new power provider have this or a similar program?

 $A\colon$ The Request for Proposals will request that this program is included in the bid specs.

Q: If voters approve the referendum, how long will it be before the program is implemented?

A: State law requires certain steps be followed to approve and implement the Electric Aggregation Program. If voters give our municipality the authority to pursue aggregation, two public hearings must be held to gather citizen input for an aggregation plan that outlines goals such as savings targets. Once the plan is created and adopted, municipal staff would seek competitive bids from energy suppliers via a formal request for proposals (RFP) process. If a bid is received that meets the goals of the plan, a contract would be negotiated.

The Public Works Department begins ice and snow control measures even before hazardous road conditions are expected.

As soon as conditions warrant it, the salting process begins on major streets designated as primary routes, hills, curves and all intersections. Residential streets that are relatively flat will be salted only at intersections. Salt remains the most cost effective means of breaking the bond between ice and the street, especially with Lemont's unique topography.

Plowing commences after snow accumulates to an inch or more. Village roadways are divided into 9 zones for the plowing process with primary routes, including hills and school bus routes being plowed first.

As soon as primary routes are cleared, crews will move on to the secondary routes. After all streets are open, trucks will begin the curbing operation.

The goal of the Public Works Department is to remove snow from all streets within six hours after the conclusion of a significant snowfall.

Your cooperation in removing vehicles from the street and observing the odd-even parking regulations will make this job easier and more efficient.



Don't Take Chances!

Winter Storms and Emergencies

If an emergency arises during a winter storm, residents should dial 911. All Public Works plowing vehicles maintain continuous two-way radio communication with the Police Department. Snow removal equipment can provide immediate support to ambulance and fire equipment.

Damaged Property

Mailboxes in the Village right-ofway are sometimes damaged during snow removal. These will be replaced with a standard rural route mailbox in the spring. To report damage, call the Public Works Department at 630-257-2532.

Holiday Safety Tips!

As the holiday season nears, please take extra precautions to keep you and your family safe. Following are tips from the National Crime Prevention Council:

While Shopping:

- Park in well lit areas and lock doors
- Purchases should be hidden in the trunk out of view.
- Avoid carrying large amounts of cash.
- Keep purse close to your body and wallets in a front pocket.
- Have a designated meeting place for older children.
- Instruct young children if lost, to go to a sales clerk at a register, request help and remain at the counter until your arrival.
- Children should never return to your vehicle in the parking lot to wait for you!
- Know where to find credit card contact information if they get lost or stolen.

At Home:

- Always lock the doors and windows of your home.
- Display gifts where they can't be seen.
- If a delivery person or solicitor comes to your door, ask for official identification through the locked door. Call to verify identity using a number you get through the phonebook or 411, not one they offer you.

Vacation Leaves:

- Use an automatic timer for your lights and radio.
- Have a friend or good neighbor watch your residence and make it look inhabited.
- Lemont Police Department offers a Vacation Watch for up to two weeks at a time. Applications are located at the kiosk in the lobby of the PD.

All Vehicles Registered in Lemont Must Obtain a Vehicle Sticker

By ordinance, all vehicles registered to an address in the Village of Lemont must obtain a vehicle sticker. The deadline to purchase stickers at the normal rate was August 1, 2011. All residents who failed to purchase a vehicle sticker will be sent a Village of Lemont Vehicle Sticker Late Notice. Passenger vehicles are now \$96.00, B plate trucks are \$120.00, and senior citizen rates are \$32.00 for the first passenger vehicle and \$64.00 for additional passenger vehicles. Anticipated mailing of this notice is the end of November. If you receive a notice for a vehicle that you no longer own, please complete the section on the form and return it to the Village Hall. Comprehensive Plan Update

Lemont's Comprehensive Plan kick off, an online survey, was a huge success thanks to the over 400 people who participated. The survey contained mostly open ended questions, asking people their thoughts on Lemont. It contained questions about Lemont today – what people love and what they'd love to change. It also asked people to give their vision for Lemont in the year 2030.

Although survey respondents provided a wide variety of input, some common concerns and valued assets appeared repeatedly. Attracting and retaining successful businesses in the Village was a primary concern for many. According to a majority of respondents the best part about living in Lemont is the quaint, small-town feel.

In November, the full results of the survey were presented at a public workshop. At the workshop, participants worked to help define a draft vision statement and key priorities for the new Comprehensive Plan.

Active Transportation Plan Update

On September 27 and October 19, the Village held two workshops to gather public input about walking, biking and transit in Lemont; approximately 50 people braved unfriendly weather conditions to participate. Additionally, over 100 people completed an online survey about walking, biking, and transit. The input from these workshops and the online survey will serve as the basis for the Lemont Active Transportation Plan.

At each workshop participants were polled about how they rate Lemont for ease of walking or biking and their priorities for bicycle, pedestrian, and transit improvements in Lemont. Participants then divided into groups and mapped their key destinations for walking and biking, barriers and hazards for bicycles and pedestrians, and locations for new bicycle or pedestrian accommodations like sidewalks or bike lanes. The groups had a lot of great discussion and provided many ideas for the Active Transportation Plan.

Active Transportation Alliance, an organization who is working to assist Lemont in the development of the Active Transportation Plan, is now working with the Lemont Active Transportation Plan Steering Committee to develop a full draft plan based on the public input received to date. The draft plan is scheduled to be available for review by the end of the year. The Steering Committee is made up of representatives from the Village, Township, Park District, and School Districts, as well as local residents.

The Active Transportation Plan is being funded by the Communities Putting Prevention to Work Model Communities grant program. In January, the Village received a \$48,000 grant from this program to fund a variety of efforts aimed at promoting increased physical activity and improved public health.
