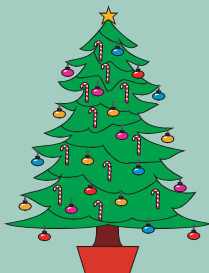

## From the Mayor's Desk

### Year in Review

The end of another year provides an opportunity to pause, reflect and assess the past 12 months, and reaffirm the commitment that we as a Village Board have made to the people of Lemont. I am proud to say that this administration's accomplishments in 2006 are on track with the goals we set as a Board almost 6 years ago.

Probably the two most significant advances this year came with the construction progress on I-355 and the beginning of Phase I of the downtown redevelopment project at 340 River Street. By negotiating with the Tollway Authority, Mayors of the Tier I communities were able to reduce the Tollway's \$20 million price tag for the interchanges to \$7.5 million. Lemont's share has been estimated at \$1.5 million. The developer and contractor for the downtown project forecast that units will be ready to occupy by the end of 2007.

The Public Works Department moved into its new \$3 million facility at 16680 New Avenue in May. By allowing vehicles and equipment to be stored inside, this modern facility will save money in equipment replacement costs for Lemont taxpayers in the long run, and should provide sufficient space for the department through the next decade.

Well # 6 was completed and on line by July 1, a \$2.7 million investment in the future of the community by increasing the water system's pumping capacity to over 6 million gallons per day. Upgrades to the water & sewer system at Illinois Street, First Street, New Avenue, and 131<sup>st</sup> Street have made the over 70 mile looped system more efficient. Road improvement

projects over the past year included the annual resurfacing program and the \$1.6 million reconstruction of River Street and Front Street in conjunction with the downtown redevelopment project, along with engineering for some of the 2007 projects.

Outsourcing some of the Village building and health inspection services, consolidating the Planning & Zoning Commission, beginning an update of the Comprehensive Plan and Zoning Ordinance, and a thorough assessment of the Village's financial condition were among the priorities also completed in 2006. Advances and upgrades in technology have made for more productive departments and improved means of communication with our residents.



## 2007 and Beyond

As a temporary measure to alleviate the overcrowding at the Police Department at 416 Main Street, the Operations Division has been relocated to the old Public Works building, including the investigative division, patrol officers and the emergency management functions.

The Board has interviewed three qualified architectural firms with an eye to beginning the design of a new permanent police facility on the former Public Works site at 127<sup>th</sup> & Archer Avenue. Once the Board has a better understanding of the financial commitment involved, methods of financing construction will be explored. A building fund was established in the 2006-07 budget.

Another capital project we look forward to completing in 2007 is the Castle Bowl dam project located behind Central School. We were fortunate this year to have escaped any serious flooding like that experienced in 2005, but the completion of this project and the previous measures taken during the past two seasons should provide an increased level of protection from severe flooding in the more flood prone areas of the village.

A special census early in 2007 in the areas of new growth will insure that the Village maximizes the revenue received from state shared funds. At the 2000 census the Village population was counted at 13,098. A special census at the end of 2004 increased that figure to 15,600 residents. In 2007, the Census Bureau will stop conducting special censuses to begin preparations for the next decennial census in 2010, so we will be able to take advantage of three years of increased state revenue based on a more accurate population figure.

Maintaining a progressive and responsive governmental organization takes a true team effort. These goals could not be accomplished without the support of our residents and the dedicated commitment of the Village Board.

## Zoning Ordinance Revisions Continue



The Zoning Commission and Community Development Department continue to update the Village's Zoning Ordinance.

Revisions to sections on residential districts, variations, non-conforming uses, and accessory uses have already been completed. These changes will go into effect on January 1, 2007.

The new regulations replace a current overlay district with a new R-4A zoning category, lower the acceptable height of residences, impose a lot coverage restriction, and reduce the permissible bulk of new homes in the older sections of town.

The amendments also provide some relaxed standards for accessory uses, which should allow homeowners more flexibility in the placement and size of such items as swimming pools and decks, and in many cases should eliminate the burden of requesting variations from the ordinance. The update also adds a new section on standards for commercial development.

The Zoning Commission will now turn attention to regulations covering business districts, review and approval procedures, signs, and fences. The Commission regularly meets on the second Monday of the month, from 5:00 to 7:00 p.m. at the Village Hall.

Citizen attendance and participation in the process is encouraged.

### Water Tower Gets a Facelift

This fall, the State Street Water Tower was cleaned, prepped and repainted. A committee consisting of Village Board members and staff met to select a color and design that would best reflect the community and the shape of the existing tower.

The project was put out to bid in September and the low bid was awarded to Maxcor, Inc. of Lockport. The project was completed on October 31.

### Don't Feed the Animals



The Village Hall has received reports over the last few months of an abundance of nuisance animals in various neighborhoods in the village. Reports have mentioned skunks, possums, raccoons and coyotes. They may have been displaced from previous habitats by Tollway and other construction.

Residents who scatter food scraps for birds and squirrels are asked to discontinue the practice. Further, we are asking residents to wrap and dispose of any food-related garbage in a securely covered trash container. If there is no source of food, these animals will seek other habitats. Your cooperation is appreciated.

## SPECIAL CENSUS PLANNED Spring 2007



The 2004 special census lists Lemont's population at 15,614. However, based on our estimates, the Village's population is already greater than 16,600.

An accurate census matters because state aid sent to municipalities is based on a per capita formula of about \$121.10 per person. If Lemont has grown by 1,000 people since the 2004 special census, which we believe it has, it will mean about \$121,100 more in yearly state aid to the Village. In order to get credit for the increased population, the Village must conduct a special census, and have the population formally certified.

It is imperative that each household that lies within the special census area participate in the process. The Special Census Questionnaire contains only six subjects: name, household relationship, sex, date of birth and age, Hispanic or Latino origin, and race. By participating in the Special Census, you will ensure that your money comes back to the Village to provide local services, instead of being spent by the State of Illinois.

The special census will only be conducted in areas of new growth. However, because the counting is done by census block, some households that participated in the 2000 census and 2004 special census will be counted again.

Generally, the special census will be conducted in areas including, but not limited, to:

- Ashbury Woods 1 and 2
- Covington Knolls 4B, 5, 6A, 7
- Rolling Meadows Phase 3
- Amberwood
- Kensington Estates 1 and 2
- Fordham Hill Estates
- South Pointe
- Briarcliffe
- Mayfair Estates

The Village has already filed the necessary paper work with the Census Bureau and is working to establish a starting date. Tentatively, the census will be conducted in early Spring.

Many community workers will need to be hired to conduct the special census. The Village will start recruiting workers in a couple of months. We will be directly contacting those that applied for the 2004 Special Census. Those who can work twenty hours a week are preferred. Census jobs are temporary in nature. Salaries range from \$9 to \$14 per hour depending on the position.

## Snow Plowing Procedures

For efficient clearing of ice and snow, village streets, consisting of more than 120 lane miles, have been divided into 8 zones. Certain major streets have been designated as primary routes and are plowed and salted first: State Street and the bridge, Hillview Drive, Stephen Street, Main Street, school bus routes and the downtown area.

As soon as primary routes are cleared, the crews move on to secondary streets, paying special attention to streets with hills. After all streets are open for travel the trucks begin a curbing operation. The goal of the Public Works Department is to remove snow from all streets within six hours after the conclusion of a snowfall.

## Salting

Salt is a key element of the snow fighting operation. Salt remains the most cost effective means of breaking the bond between ice and the street, especially with Lemont's unique topography. This operation is critical on curves, hills, bridges and intersections.

## Damaged Property

Mailboxes in the Village right-of-way are sometimes damaged during snow removal. These will be replaced with a standard rural route mailbox in the spring. To report damage, call the Public Works Department at (630) 257-2532.



## Winter Storms and Emergencies

If an emergency arises during a winter storm, residents should dial 9-1-1. All Public Works plowing vehicles maintain continuous two-way radio communication with the Police Department. Snow removal equipment can provide immediate support to ambulance and fire equipment.

## Carbon Monoxide Detectors Required Effective January 1

Effective January 1, 2007, every dwelling must be equipped with at least one carbon monoxide alarm within 15 feet of every bedroom. Detectors can be either hard wired or battery operated. A building permit may be required for hard wired detectors.

This Illinois statute applies to single family homes and multi-family buildings using gas or other fossil fuel for heat, ventilation or hot water.

Carbon monoxide is a silent killer. You can't see it or smell it. Do your family a favor if you do not already have a detector.

## Community Development Block Grant Funds Available

The Cook County Community Development Block Grant Program has funds available to correct code violations and replace roofs, furnaces, siding and windows for qualifying households that meet income guidelines. No monthly payments or interest. Homes will be liened for the full dollar amount of the rehabilitation and the funds are repaid only when the house is sold.
