


#### From the Mayor's Desk-

Mayor Leads Task Force on Junkyard Clean-Up

Wouldn't it be nice to drive along Route 83 during the summer with your window open and not view the mountains of junk cars, old tires and scrap metal as you approach the intersection of Archer Avenue and Route 83 in unincorporated Lemont Township? If a recently formed multi-jurisdictional task force has its way, the face of that area will be changed forever.

Our investigation also unearthed the fact that the Attorney General's Office, on behalf of the Illinois Environmental Protection Agency, was successful in getting a Consent Order issued in May of 2001. The court order cites numerous violations of the IEPA regulations and standards. The IEPA performed another site inspection in January of this year and has reported findings that almost all of the previously noted violations still exist.

The property owner has indicated that he has been trying to sell. However, we will not delay our pursuit of enforcement of the Consent Order for any reason. I am firmly committed to doing everything within my power to transition this embarrassment for the surrounding communities into the gateway that Lemont deserves.

The Bottom Line -

As most of you are aware, the state and federal governments are in dire financial condition. Consequently, revenues from these sources at the local level will continue to decrease in the upcoming years. Complicating the matter is the reality that the Village will have to undertake several capital improvement projects during the next five years in order to maintain the level of service that our residents deserve.

We continue to separate many miles of the combined sewer system on an annual basis, as required by law. Additionally, we have plans to move our Public Works facility to a more suitable location. There are plans to build a new Police facility which is long overdue for expansion. Several projects are in the 2004 budget to help alleviate recurring flooding problems.

As part of our planning process for these projects, we will be discussing various ways to increase revenue sources within the Village. This administration will have to make some very difficult decisions in order to accomplish our goals.

In all likelihood, residents can expect a water and sewer rate increase. The water rate has not been increased in over 6 years and the sewer rate has not been touched since its inception in 1992. We are very mindful of the effect this will have on our senior citizens, many of whom are on a fixed income. Therefore, we will attempt to protect the senior population by keeping the water rate stable at the minimum usage level. The increase will be targeted at the higher usage levels which we believe is an equitable approach.

We will also be discussing the possibility of asking the residents to decide whether or not the Village should be given the authority to implement additional revenue generating powers. The thought process is that a substantial portion of the tax burden can be shifted to non-residents with something as simple as a modest sales tax increase.

We are in the midst of our budget process as this newsletter goes to press. We are committed to being very judicious in our expenditures and we will deliver a balanced budget. As always, we will continue to seek your input and will execute the mandate that we are given.



# Village Wins APWA Awards for Heritage Quarries Park

Lemont's Heritage Quarries Park and trail extension has recently received two accolades from the American Public Works Association Southwest Branch and Chicago Metro chapters. Named as Project of the Year in the category of historic preservation for projects under \$2 million, the Park is now eligible for a national award.

Four pedestrian bridges and a 3.8 mile trail extension will provide access to the public for hiking, biking and fishing opportunities in a pristine natural area previously inaccessible for recreational opportunities.

Volunteer labor and the Public Works Department cleared discarded debris from the area to complete the path extension. The Public Works Department then constructed a 10-foot wide path, surfaced with asphalt grindings and looped around several quarry lakes.

Remaining improvements to the Park include construction of a parking lot and a shelter as soon as weather permits. The Park's official opening is scheduled for June.

Park improvements were made possible through a Legislative Initiative/Illinois First grant through the Department of Commerce and Economic Opportunity. Contributions from private industry also funded some of the park amenities.

# Village Prepares for Well #6 Construction

A water system study conducted a year ago by Strand & Associates revealed that in order to meet current and future water consumption needs through the year 2010 it would be necessary to build a new well by 2005 (Well #6), and possibly a second additional well prior to 2015 (Well #7). The estimated cost of construction for Well #6 is \$2.6 million.

Property for Well # 6 was acquired through a 1996 annexation agreement and will be located adjacent to Steeples development with access off McCarthy Road. The new deep well will be drilled to a depth of approximately 1,650 feet with a capacity of 1,000 gallons per minute. Pumping facilities and an ion exchange plant will be enclosed in a masonry building on the site. On January 26, the Village Board accepted the low bid for well drilling services from Layne Western to begin Phase I of a year-long project. It is anticipated that the well project will be complete by spring, 2005.

A municipal bond issue will finance the initial improvements. A water & sewer rate increase will most likely be necessary to cover the debt service on the bonds. Water rates have not changed since 1998; sewer rates have remained constant for the last 12 years. The average residential bill is now \$49.45 per 2-month billing cycle, roughly 83 cents per day. The Village Board will weigh every option to provide the least impact to the consumers.

The Illinois EPA has determined that the Village's well supply meets or exceeds all of the state and federal water requirements in regard to water quality. Additionally the water levels in all of the Village's deep wells has been on the rise in recent years. The IEPA has also determined that the water supply has a low susceptibility to contamination based on a recent Source Water Assessment.

# WHAT YOU SHOULD KNOW ABOUT TORNADOES



The Lemont Environmental Advisory Commission, in partnership with Lemont Police and Fire Departments, has made a brochure available on tornado safety. The text is reproduced below. Free copies of the brochure are available at the Village Hall, 418 Main Street, or on the Village web site at www.lemont.il.us.

#### How Will You Know That a Tornado Could be Headed Your Way?

The tornado siren will sound to warn resident of imminent weather emergency in the following situations:

- A tornado, rotating wall cloud or funnel cloud aloft is reported within a ten-mile radius based from the center of Lemont.
- When reported that a tornado has touched down in Lemont Township.
- When wind gusts are clocked in excess of 50 m.p.h.
- Any time the National Weather Service advises a warning which will impact the Village and Township.

Once activated, the sirens will not be reactivated for at least one hour unless a rotating wall cloud, funnel cloud aloft or tornado has been sighted and is a clear and present danger to the Village or Township.

## THERE WILL NOT BE AN ALL-CLEAR SIREN.

#### Prepare a Home Tornado Plan

Pick a safe area where family members could gather if a tornado is headed your way. It could be your basement, a center hallway, bathroom, or closet on the lowest floor. Avoid areas with glass. Keep the chosen area uncluttered.

# When a Tornado WATCH is issued . . .

- Listen to local radio and TV stations for further updates.
- Be alert for changing weather conditions.
- Blowing debris or the sound of an approaching tornado may alert you.
   Many people say the sound of a tornado is like a freight train.

# When a Tornado WARNING is issued. . .

- If you are inside, go to the designated safe area. The tornado may be approaching your area.
- If you are outside, hurry to the basement of a nearby sturdy building or lie flat in a ditch or low lying area.
- If you are in a car or mobile home, get out immediately and head for safety (as above).
- Do not attempt to pick up children from school or childcare facilities. They will prepare for a tornado accordingly.

#### What You Should Know About Tornadoes

#### **Assemble a Disaster Supplies Kit Containing:**

- First aid kit and essential medications.
- Canned food and manual can opener.
- Drinking water.
- Clothing, bedding or sleeping bags.
- Battery-powered AM radio, flashlight and extra batteries.
- Special items for infant, elderly, or disabled family members.
- Written instructions on how to turn off electricity, gas and water if authorities advise you to do so. (Remember, you may need a professional to turn gas service back on.)
- A commercially available Weather Radio for National Weather Service announcements.
   (Approximate cost is \$25.00). Make sure to replace the batteries at least annually.

#### **Stay Tuned for Storm Warnings:**

- Listen to your local radio and TV stations for updated storm information.
- Know what a tornado WATCH and tornado WARNING means:
  - A Tornado WATCH means a tornado is possible in your area.
  - A Tornado WARNING means a tornado has been sighted and may be headed for your area. Go to a safe area <u>immediately</u>.

#### After a Tornado Passes . . .

- Watch out for fallen power lines and stay out of damaged areas.
- Listen to the radio for information and instructions.
- Use a flashlight to inspect your home for damage.
- Avoid the use of candles, due to the possibility of gas leaks.



#### Odor Alert Network Formed

Although odor complaints are received only sporadically by the Village and the source of the odor may be miles away, Village officials have implemented a procedure to deal with odor complaints effectively. The Lemont Odor Alert Network, a partnership of Village government, the Illinois E.P.A., local industries, businesses and residents, has been meeting over the course of several months to refine a procedure to help identify and resolve odor problems.

A recurring problem in resolving odor complaints in the past has been the inability to quickly investigate the complaint and get accurate information on wind direction. Through the Odor Alert Network, an investigation of the complaint can begin immediately. When odors are reported by residents to the Village Hall, Police or Fire Departments, the OAN coordinator will attempt to verify the odor through a sentry network (a group of residents strategically located throughout Lemont). The coordinator will then investigate and attempt to resolve the complaint with the suspected source of the odor.

This process does not replace or interfere with the regulatory requirements already in place by the Illinois E.P.A. If a release of a substance occurs that is required by law to be reported to emergency officials, the organization responsible for the release must still report the release.

Two new WeatherNet weather monitoring stations, financed by a \$10,000 donation from Unocal/Chicago Carbon Company, have been located at Old Quarry Middle School and Lemont High School. The stations can provide accurate and immediate information on wind direction.

#### **Emergency Operations Plan Revised**

Tom Ballard, Lemont Emergency Management Agency Coordinator, has completed revisions to the Village and Township Emergency Operations Plan to comply with homeland security and Illinois EMA requirements for certification of the plan. A sound emergency operations plan is critical in any disaster effort.

The Plan is essentially a manual to be used by officials and agencies normally involved in mitigation of the disaster. The Lemont Emergency Operations Plan will be used as a model for Cook County and other emergency management agencies.

#### Landscape Waste Pick-up to Begin April 1

The landscape waste pick-up program will resume on April 1 and continue through the end of November. Yard waste will be collected on your regular trash pick-up day. To guarantee timely pick-up, landscape waste must be placed in a biodegradable paper landscape waste bag up to 33 gallons in capacity. LANDSCAPE WASTE IN CANS CANNOT BE ACCEPTED.

Place landscape waste at the curb prior to 6:00 a.m.

#### Landscape Waste Sticker Required

Stickers may be purchased at the Village Hall, Lemont Township Office, Chipain's, Jewel Foods, Peterson's Hardware, Sears Hardware, and Totura's. The cost per sticker is \$2.00.

Paper landscape waste bags may be purchased at the Village Hall at \$.30 each or at local grocery and hardware stores.



# Branch Pick-up Program Begins April 1

The annual branch/brush pick-up program will begin on April 1 and continue through the end of November. Branches and tree limbs will be picked up on the regular trash pick up day by Waste Management.

#### **BRANCHES MUST BE TIED:**

- less than 4 feet in length.
- less than 4 inches in diameter.
- less than 50 pounds.
- tied with biodegradable string/ twine (no wire)

BRANCHES IN CANS CANNOT BE ACCEPTED.

NO LANDSCAPE STICKER IS REQUIRED FOR BRANCHES. THIS IS A FREE SERVICE.
