## **BACKGROUND/HISTORY**

On January 28, 2013 the Village Board adopted an ordinance authorizing the process to issue alternate revenue source bonds to fund the Lemont Sports Complex project. Because this type of bond has the statutory ability to be levied on residents' tax bills if all other pledged existing revenue sources proved to be insufficient to cover debt service (facility revenue, sales tax, income tax, TIF increment), the bond has a petition process built into it that allows for the residents to send the question to referendum for the residents to consider the bonds. Subsequent to the passage of the ordinance, several residents exercised this petition option, and in order to utilize this type of bond, a successful referendum would be required.

Over the last several months, the Village has been researching alternative methods to finance the project that would give residents assurances that there would be no property tax levied as part of the project. After reviewing several options, the Board is close to presenting an option to finance the project utilizing a financing tool that has no statutory to levy property tax against the residents, and consequently would not require a referendum.

The last day to officially submit the alternate revenue bond question to the county clerks for certification to be on the ballot for this March is January 9<sup>th</sup>. If the Village Board chooses to pursue other options and <u>not</u> place the question on the ballot, Village bond counsel has recommended that a repealing ordinance be passed prior to the January 9<sup>th</sup> filing deadline. The Village Board does not have a regularly scheduled meeting prior to this date, hence the need for the special meeting on January 6<sup>th</sup>. Village Bond Counsel has drafted an ordinance that would effectively repeal the previously passed authorizing ordinance, if approved by the Village Board.

WHEREAS, the Village of Lemont, Cook, DuPage and Will Counties, Illinois (the "Municipality"), operates in accordance with the provisions of the Illinois Municipal Code [Section 5/1-1-1 et seq. of Chapter 65 of the Illinois Compiled Statutes, as supplemented and amended, and the Municipality's President and Board of Trustees (the "Corporate Authorities") in Ordinance No. O-10-13, adopted January 28, 2013 (the "Preliminary Ordinance") preliminarily determined to undertake the acquisition, construction and installation of a Lemont Sports Complex, and related facilities, improvements and costs (collectively, the "Project") and now finally determines not to forward with the Project.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LEMONT, COOK, DUPAGE AND WILL COUNTIES, ILLINOIS, as follows:
