MINUTES

VILLAGE BOARD MEETING October 25, 2010

The regular meeting of the Lemont Village Board was held on Monday, October 25, 2010 at 7:00 p.m., President Brian Reaves presiding. Roll call: Blatzer, Chialdikas, Miklos, Sniegowski, Stapleton, Virgilio; present.

III. CONSENT AGENDA

Motion by Chialdikas, seconded by Blatzer, to approve the following items on the consent agenda by omnibus vote:

Roll call: Stapleton, Virgilio, Blatzer, Chialdikas, Miklos, Sniegowski; ayes. Motion passed.

IV. MAYOR'S REPORT

Motion by Blatzer, seconded by Stapleton, to approve a Proclamation for the Retirement of Village Treasurer Jean Nona. Voice vote: <u>6</u> ayes. Motion passed.

Motion by Chialdikas, seconded by Blatzer, to approve a Proclamation for the 30th Anniversary of John Paul II Polish School. Voice vote: 6 ayes. Motion passed.

Motion by Stapleton, seconded by Sniegowski, to open a Public Hearing on the Annexation Agreement for an approximately 8.7 Acre Parcel at the SW Corner of McCarthy Road & Bell Road. James Brown gave some background on this proposed annexation agreement. There is no site plan included at this time.

Jim Blue, 25 Sunhill Lane, stated he doesn't know which municipality he'd be better off annexing to. The Mayor assured him Lemont is not looking to force annex other properties.

Pat Browne, 2841 Artesian Street, asked what is meant by a drive-thru. A partner of the development company said the plan was to have a mixed use office site with low density. Ms. Browne asked if the Village would get water & sewer to them which we would.

Ray Turano, Equestrian Estates, said the Palos Park Board had asked for his trust. He's like to see more planning first by either municipality. Whatever goes up first will determine the rest of the development in the area.

Ed Boschwinski, property owner adjacent to the property in question, doesn't see how the Village can approve zoning before we have a plan. He asked why this is different.

Deborah Bechtlofft, 26 Sunhill, said the development will be in her backyard. She feels it will devalue her property.

Charles Englund, 20 W. 115th Street, feels this annexation is premature even with the pressure of Palos Park.

Jeanette Daubaras, Derby Road, asked if municipalities can go through forest preserves to annex. The Village Attorney, Dan Blondin, said it is possible to do that but certain conditions must be met. He will look into this to make sure those conditions have been met. Mrs. Daubaras also said the annexation agreement is not complete since there is no plat of annexation, survey, etc. She feels we should not change the zoning before annexing, leaving it R-1.

Debbie McClough has a house that backs up to Bell Road and asked about the Cook County Highway Department widening that road to 5 lanes.

Patty Wintercorn, said she thinks the Village should go slow with this annexation.

Trustee Blatzer said she doesn't believe in doing things this way, but we have to trust our ordinances under these circumstances.

Trustee Chialdikas wants to block the Palos Park annexation and protect our community.

There being no further comment, a motion was made Stapleton, seconded by Sniegowski, to close the public hearing. Voice vote: <u>6</u> ayes. Motion passed.

Motion by Blatzer, seconded by Miklos, to open a Public Hearing on the Annexation Agreement for an approximately 22.67 Acre parcel located at the Northwest Corner of McCarthy & Bell Roads. Voice vote:

6 ayes. Motion passed. James Brown provided the background on this proposed annexation.

Tom Shark asked about how many homes would be proposed for the residential part of the property. The developer responded about 30.

Tom Ludwig, Porter Street, said his deceased relatives would not like their former property to become part of Palos Park.

Jeanette Daubaras asked if there are wetlands in that property, and was told about one acre.

Charles Englund mentioned the taxing entities would be affected by an annexation by Palos Park.

There being no further comment, a motion was made by Stapleton, seconded by Sniegowski to close the Public Hearing at 8:30 p.m. Voice vote: <u>6</u> ayes. Motion passed.

BACKGROUND/HISTORY

The Illinois General Assembly amended the Illinois Open Meetings Act stating specifically the following:

"Any person shall be permitted an opportunity to address public officials under the rules established and recorded by the public body."

Currently, the Village of Lemont does not have formal rules for addressing the public body. The only established rules are Roberts' Rules of Order which covers the process and procedures for how business is conducted.

As a result, corporation counsel drafted an ordinance concerning public comment at a public meeting based on how this is currently handled informally. This includes the ability of one to address the board during the Audience Participation on the agenda as well as during debate on a specific agenda item. Further, it allows the President certain discretion to set time limits as needed based on accounting for the number of speakers on a subject matter and other additional business items on the agenda. However, the rules also allow for provision to seek additional time to speak.

The effective date of this ordinance will be January 1, 2011.

RECOMMENDATION

ORDINANCE NO. 2010-

An Ordinance Amending Chapter 2 of the Lemont, Illinois Municipal Code Relating to Rules of Order for Village Board of Trustees Meetings

WHEREAS, the Village of Lemont ("Village") is an Illinois Municipal Corporation pursuant to the Illinois Constitution of 1970 and the Statutes of the State of Illinois;

WHEREAS, the Village's Boards and Commissions are subject to the provisions of the Illinois Open Meetings Act, 5 ILCS 120/1 et. seq.; and,

WHEREAS, the Illinois General Assembly has amended the Illinois Open Meetings Act by adding Section 2.06(g) of that Act which provides, "Any person shall be permitted an opportunity to address public officials under the rules established and recorded by the public body" (5 ILCS 120/2.06(g));

WHEREAS, the Village President and Board of Trustees find that communication between the public and Village officials is an important and necessary function of the government; and,

WHEREAS, the Village President and Board of Trustees find that such comments should be made with decorum and should be integrated into Village Board meetings so as to allow for equal time for any person who desires to address the Village Board.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT and BOARD OF TRUSTEES OF THE VILLAGE OF LEMONT, COOK, DUPAGE AND WILL COUNTIES, ILLINOIS, as follows:

SECTION ONE: The Lemont, Illinois Municipal Code ("Village Code"), as amended, is hereby further amended by adding in its entirety the new section 2.08.060 as indicated as follows:

2.08.060 PUBLIC COMMENT.

Persons who wish to address the Board on any matter may request recognition prior to the meeting, or during Audience Participation, or if the matter relates to a specific agenda item, during the discussion of that item. The President will attempt to accommodate such requests to the extent practicable by directing that such requests shall be heard during Audience Participation or during debate on a specific agenda item. The President may in his discretion set a time limit for each person's address, taking into account the number of persons wishing to be heard on a matter and the amount of village business requiring attention. The President or a majority of the Trustees present may extend the limitation of time or grant additional time to individual speakers and the President's denial of or limitation on any request may be overruled by a majority of the Trustees present. Provided, any failure to adhere to the provisions of this section, and any such restriction or limitation upon any speaker, shall not impair or affect any ordinance, resolution, motion or other action of the Board.

SECTION TWO: <u>Publication</u>. That the Village Clerk of the Village of Lemont be and is directed hereby to publish this Ordinance in pamphlet form.

SECTION THREE: Effective Date. This Ordinance shall be in full force and effect from its passage, approval and publication as provided by law, and shall be applicable at all meetings held on or after January 1, 2011.

BACKGROUND/HISTORY

During the course of the past year and a half, Village staff has been reviewing with the board the status of the water and system infrastructure and specific project prioritization that need to be done. Highlighting the list of projects include replacement of water softeners at the State Street and Houston Street wells, Houston Street water tower repairs, water main replacements, storm sewer separation and sanitary sewer system improvements. The bonds, if issued, would be paid for by revenues of the water and sewer system. The bond payments, as currently structured, would maintain about the same level debt service that is currently being paid, except the first few years. Further, staff is anticipating use of Build America Bonds due to the low interest rates in the current market place.

This ordinance is the first step in the process to issue the bonds. There will be BINA hearing on November 22 before the Village Board and the Final Bond Ordinance is anticipated to be before the board on December 13th.

AN ORDINANCE AUTHORIZING THE ISSUANCE OF UP TO \$5,500,000 WATERWORKS AND SEWERAGE REVENUE BONDS AND ALTERNATE REVENUE SOURCE BONDS (IN LIEU OF SUCH REVENUE BONDS) OF THE VILLAGE OF LEMONT, COOK, WILL AND DUPAGE COUNTIES, ILLINOIS, TO FINANCE WATERWORKS AND SEWERAGE FACILITY IMPROVEMENTS

PREAMBLES

WHEREAS, the Village of Lemont, Cook, Will and DuPage Counties, Illinois (the "Municipality"), operates its municipally-owned combined Waterworks and Sewerage system (the "System") in accordance with the provisions of Division 139 of Article 11 of the Illinois Municipal Code [Section 5/11-139-1 et seq. of Chapter 65 of the Illinois Compiled Statutes, as supplemented and amended, including by the Local Government Debt Reform Act (collectively, the "Act")] and is entitled to receive a certain distributive revenue share of proceeds from (i) the State of Illinois income taxes (such distributive share referred to herein as the "Revenue Sharing Receipts") imposed by the State of Illinois pursuant to the Illinois Income Tax Act and distributed pursuant to the State Revenue Sharing Act and (ii) of the Retailer's Occupation Taxes, Service Occupation Taxes, Use Taxes and Service Use Taxes (collectively "Sales Taxes") distributed pursuant to applicable law, and may be eligible to receive interest subsidy payments ("Interest Payments") under the American Recovery and Reinvestment Act of 2009; and

WHEREAS, the Municipality's President and Board of Trustees (the "Corporate Authorities") has determined that it is advisable, necessary and in the best interests of the Municipality's public health, safety and welfare to finance the acquisition, construction and installation of new replacement softeners at the State Street and Houston Street water wells, Houston street water tower repairs and rehabilitation, general storm sewer separation, general sanitary sewer repairs, general water system improvements, and related facilities, improvements and costs (including, as applicable, land acquisition and rights in real estate, mechanical, electrical and other related facilities, improvements and costs, collectively, the "Project"), pursuant to the preliminary plans and specifications therefor prepared by the Municipality's consulting engineers concerning the Project; and

WHEREAS, in connection with the estimated costs of the Project, up to \$5,500,000 in aggregate principal amount is to be paid from proceeds of the hereinafter described Alternate Bonds (and any balance from funds on hand or grant proceeds, as the case may be), being general obligation in lieu of revenue bonds as authorized by Section 15 of the Local Government Debt Reform Act, but nevertheless expected to be paid from one or more of the revenues of the System, Interest Payments, Revenue Sharing Receipts, and Sales Taxes as the alternate revenue sources rather than by any levy of taxes, and the balance from other available funds, with respect to which authorization is necessary to issue the same aggregate principal amount of Waterworks and Sewerage revenue bonds (howsoever styled, the "Revenue Bonds") and to issue up to the same principal amount of general obligation bonds (one or more of waterworks and sewerage revenues, Interest Payments, Revenue Sharing Receipts and Sales Taxes as the alternate revenue sources) (howsoever styled, the "Alternate Bonds"), provided,

however, that only one set of such obligations be issued: either Revenue Bonds or Alternate Bonds in lieu of such Revenue Bonds; and

WHEREAS, such costs are expected to be paid from, as the case may be, funds on hand, grant proceeds, if any, and proceeds of the Alternate Bonds, to be payable from one or more of the revenues of the System, Interest Payments, Revenue Sharing Receipts, and Sale Taxes and issued pursuant to the Act, this ordinance and one or more ordinances supplemental to this ordinance authorizing and providing for the issuance of Alternate Bonds in lieu of the Revenue Bonds, prescribing the details of such obligations and providing for the collection, segregation, distribution and application of one or more of the revenues of the System, Interest Payments, Revenue Sharing Receipts, and Sales Taxes to pay the Alternate Bonds or Revenue Bonds, as the case may be, in either case to be in lieu of any levy of taxes; and

WHEREAS, the Municipality has insufficient funds to pay the costs of the Project and, therefore, must borrow money and issue Revenue Bonds, to be included in an issue of Alternate Bonds, if authorized to be issued in lieu of the Revenue Bonds, in evidence thereof, at one time or from time to time and in one or more series, in an approximate principal amount aggregating not to exceed \$5,500,000 for such purposes (Alternate Bonds and Revenue Bonds separate not to exceed \$5,500,000 in the aggregate), pursuant to and in accordance with the provisions of the Act.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LEMONT, COOK, WILL AND DUPAGE COUNTIES, ILLINOIS, as follows:

Section 1. Incorporation of Preambles and Determination to Issue Bonds. The Corporate Authorities hereby find that all of the recitals contained in the preambles to this ordinance are true, complete and correct and hereby incorporate them into this Section 1 of this ordinance by this reference thereto. It is necessary and in the best interests of the Municipality to acquire, construct and install the Project for the public health, safety and welfare, including in accordance with the plans and specifications, as described above, and that the System continue to be owned and operated as a combined municipal Waterworks and Sewerage system in accordance with the provisions of the Act, and that for such purposes there are hereby authorized to be issued and sold not to exceed \$5,500,000 in aggregate principal amount of Revenue Bonds, or the same amount of Alternate Bonds in lieu of the Revenue Bonds (Alternate Bonds and Revenue Bonds separate not to exceed \$5,500,000 in the aggregate).

Section 2. Publication and Notice. Within ten (10) days after the adoption of this ordinance by the Corporate Authorities, this ordinance, preceded by the notices hereinafter described, shall be published in a qualifying newspaper (as described in the Notice by Publication Act, 715 ILCS 5/0.01 et seq.) published (if any), and of general circulation within the Municipality, and (a) concerning the Alternate Bonds -- if no petition, signed by not less than registered voters of the Municipality numbering the greater of (i) 7.5% of the registered voters in the Municipality or (ii) 200 of those registered voters or 15% of those registered voters, whichever is less, is filed with the Village Clerk of the Municipality within thirty (30) days after the date of the publication of this ordinance, preceded by the Alternate Bond notice hereinafter described, asking that the question of the issuance of the Alternate Bonds to pay costs of the Project, and related expenses, be submitted to the electors of the Municipality, and/or (b)

concerning the Revenue Bonds -- if no petition signed by not less than the number of electors equal to 10% of the number of registered voters in the Municipality is filed with the Village Clerk of the Municipality within thirty (30) days after the date of the publication of this ordinance, preceded by the Revenue Bond notice hereinafter described, asking that the question of the issuance of the Revenue Bonds to pay costs of the Project, and related expenses, be submitted to the electors of the Municipality: then this ordinance shall be in full force and effect, and the Revenue Bonds, or the Alternate Bonds in lieu of such Revenue Bonds, as the case may be, shall be authorized to be issued by this ordinance and related proceedings supplemental to this ordinance. If an applicable petition is filed, an election on the question shall be held as set forth in the forms of the notices required by Sections 5 and 15 of the Local Government Debt Reform Act, and this ordinance shall not become effective as to the Revenue Bonds and/or the Alternate Bonds, as the case may be, until the applicable question or questions shall have been duly approved by a majority of the votes cast on the applicable question or questions at the election to be held as set forth in the applicable notice or notices. The Village Clerk shall have available and provide an applicable form of petition to any person requesting one. The Village Clerk shall give notice of the foregoing provisions as set forth in substantially the forms of such notices as are presented at the meeting of the Corporate Authorities at which this ordinance is adopted, modified as may be necessary for completeness and to comply with the Act.

Section 3. Additional Ordinances. If no petition meeting the requirements of applicable law is filed as provided above in Section 2, then the Corporate Authorities in accordance with and pursuant to the Act may adopt additional ordinances or other proceedings supplemental to or amending this ordinance, providing for the issuance and sale of up to but in any event not to exceed \$5,500,000 in aggregate principal amount of the Revenue Bonds, or the same aggregate principal amount of Alternate Bonds in lieu of such Revenue Bonds, prescribing the details of such Alternate Bonds or Revenue Bonds, providing for the collection, segregation, distribution and application of one or more of the revenues of the System, Interest Payments, Sales Taxes and Revenue Sharing Receipts for the payment thereof, and, in the case of the Alternate Bonds providing for a levy of taxes as further security and source of payment, although expected to be paid from one or more of System revenues, Interest Payments, Revenue Sharing Receipts and Sales Taxes and not any levy of taxes. Such additional or supplemental ordinances or other proceedings shall in all instances become effective in accordance with applicable law; and this ordinance, together with such supplemental and additional ordinances or other proceedings, shall constitute complete authority for the issuance of the Alternate Bonds and/or the Revenue Bonds under applicable law (but in any event not to exceed \$5,500,000 in aggregate principal amount separate). Alternate Bonds are expected to be issued in lieu of Revenue Bonds.

Section 4. Severability and Repealer. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance. All ordinances, resolutions or orders, or parts thereof, in conflict with the provisions of this ordinance are to the extent of such conflict hereby repealed.

BACKGROUND/HISTORY

Pursuant to the Illinois Municipal Code (65 ILCS 5/8-7-1 et seq.) the Village of Lemont has established and maintained a Working Cash Fund. The primary purpose for this fund to ensure the treasury has sufficient funds available to meet necessary expenditures in anticipation of real estate taxes. This year, Cook County will be significantly behind in providing these funds to the various local governments. To ensure sufficient funds are available, staff is requesting authorization to transfer from working cash up to \$700,000 to cover costs to the general corporate account. Upon receipt of property taxes, the working cash fund would be replenished the amount transferred.

WHEREAS, in order to provide money with which to meet general and special corporate, Working Cash Funds may be transferred in anticipation of receipt of property taxes; and,

WHEREAS, it has been determined that there are funds within the Working Cash Fund available for this purpose.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LEMONT, AS FOLLOWS:

SECTION 1: The Village Treasurer is hereby authorized and directed to withdraw up to Seven Hundred Thousand Dollars (\$700,000) from the Working Cash Fund and transfer said amount to the General Corporate Fund. The Working Cash Fund will be refunded with first dollars received from property taxes upon disbursement from the County Collector

SECTION 2: That the Village Clerk of the Village of Lemont be and is directed hereby to publish this Ordinance in pamphlet form, pursuant to the Statutes of the State of Illinois, made and provided.

SECTION 3: Should any Section or provision of this Ordinance be declared by a Court of competent jurisdiction to be invalid, such decision shall not affect the validity of the Ordinance as a whole or any part thereof other than the part declared to be invalid.

SECTION 4: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
