Mona will post the distressed flyers when completed to possible artists. The submission deadline is June 30<sup>th</sup>. The artists will be notified by July 18<sup>th</sup>. The exhibit will be judged. Leslie, Joe, and Randy will install the exhibit on July 17 and take it down September 17<sup>th</sup>. The tentative reception date is Friday, July 21<sup>st</sup>.

The commissioners reviewed some of the projects and events that the commission has held over the years: 3 Black and White Painting Jams, Barbershop Quartet performance, 2 mosaic projects (the Village planters and the bridge downtown), Art Walk (in collaboration with the Lemont Historical Society), 2 Art/Music Festivals (held both downtown and uptown), Sidewalk Chalk event, Yarn Bomb, Umbrellas for Peace (various events involving seniors, students, and a parade), 2 large outdoor murals (Rudy Kling and the Protest), and hosting free children's art activities at all of the village festivals including Halloween Hoedown, Heritage Fest, and Hometown Holidays besides opening, staffing, and maintaining the Lemont Art Center.
