- 2. Brian Pepich, President of the Park District Board, asked that we table the vote on Vistancia since their District wasn't informed by the Township of all of the details. They do not meet again until the 18th of this month so they would like to have it tabled until after that.
- 3. Tony Spinelli, Chairman of the Planning and Zoning Committee, said there are engineering issues in Vistancia that should be discussed (perhaps during the final engineering), not necessarily before then.
- 4. Tom Redriesh owns property next to the Vistancia property and would like them to mitigate the water running down the north side.
- 5. Michelle Nagel Fleener said that she thinks we should not build there to preserve Lemont's natural beauty.
- 6. Mr. Brown feels the quality, not quantity, is more important. He feels the people should get to see the final plot, not the preliminary plan.
