Old Business

The minutes from August were reviewed and accepted as corrected by Emily and seconded by Susan. The June minutes are still locked into the old laptop. Sue will present them once a new laptop is purchased and the files transferred. Sue reported that the accumulated account has a balance of \$36,418.29 and \$2,691.16 in the budget account.

Mona and Sue had approximately 100 participants at Heritage Fest. They accumulated \$5.75 in donations.

There is no new information about the possible Lemont Arts Council.

Susan presented two estimates for UV protection film for the Center with samples. The commissioners agreed on the film color, neutral series. Sue made the motion to spend \$1119.64 to complete the project by Sunset Glass Tinting. Emily seconded the motion and all of the attending commissioners were in agreement.

Leslie has not decided on a printer and laptop for Sue to purchase for the Center.

Committee Reports

Village – Ron stated that the construction on McCarthy road will extend till next year.

Volunteer Coordinator – Emily stated that there are some open spots during the next month. Volunteers are needed.

Art Organizations – Mona reported that the Lemont Art Guild meets the third Wednesday of each month. September 20th, is the next meeting. The guild held a reception at the Center in celebration of the end of summer on August 31st with 24 participants.

Fundraising – The commissioners discussed the possibility of holding art lectures. The Center would need a projector and working laptop. The commissioners discussed the possibility of holding another Gala in the spring 2019. A full board would be required.

March through April will be a collaboration with the Illinois Poetry Society.
