The commissioners discussed holding a Community Reception that includes various organizations including, but not limited to Lemont Jr. Women's C, Park District, various churches, the Art Guild, the Chamber, and Timberline Knolls. Another possible event discussed as an event for the Illinois Arts Month in October was a concert.

Sue's email proposal of the commission's duties and responsibilities yielded little response, but discussion continued.

Mona applied for consideration in the distribution of the Mayor's Drive for Charity money.

Possible projects/programs for consideration in applying for the NEA grants include: Personnel salary, Industry Night, and a Program Night. Dana will be attending the next meeting to assist the commission with the grant process. Ron will obtain the required numbers from the Village that we need for the applications.

Dave Walters stated that Night Blue have received \$16,000 from grants that is earmarked for their summer programs. After discussion, Sue made the motion to lend Night Blue \$2000 for their security deposit at the old Blockbuster site that is contingent upon a mutually agreed upon contract. All commissioners present agreed with the motion with Dave and Eric courteously abstaining due to the fact that they have a conflict of interest in this motion.

The next meeting is scheduled on Tuesday, June 14, 2011 at 7:00 p.m. The meeting adjourned at 9:36 p.m. with Eric making the motion and Dave seconding.
