# Fundraising

### **New Business**

The exhibit of senior citizen paintings from Emeritus will be ending the week of July 24<sup>th</sup>. The next exhibit will be of art therapy pieces from Timberline Knolls. Sue and Mona will be dismantling the current show and hanging the new show. There may be an opening reception for the new exhibit. The date has yet to be determined.

Mona, Barb, and Dana are working very hard putting in many hours on the NEA grant proposal. Ron will be responsible for obtaining the required endorsement letters, names of the village representatives, and ascertain who should be named as the project director. Sue will need to complete the financial requirements for the grant.

Cell/phone service and internet access appear to be priority purchases for the Center. Mona called Comcast and was quoted \$109 a month for these services. A website also appears to be a need. Eric is going to research domain names and financial costs. Thank you, Eric for assisting in this area.

The Halloween Hoedown is in October. October is the Illinois Arts Month. Discussion for a new event ensued, but not finalized.

Mona, Eric, Dave and Sue have renewed their commissions. Ron will clarify if any conditions are required for the commissioners.

The next meeting is scheduled on Tuesday, August 9, 2011 at 7:00 p.m. The meeting adjourned at 9:10 p.m. with Barb making the motion and Eric seconding.
