Martha Glas attended our meeting. She is very knowledgeable and as a result there is better communication/information between the Commission and the Village.

#6054 - Lemont Green Initiatives: A Natural Resource Element has been added to the Village Website.

#6056 - Oxbow Midwest Calcining: The plant is closed and will spend one year closing down/mothballing the facility

#6057 - Environmental Checklists: The final checklist was given to M. Glas. It is the Commission's hope this will be utilized where applicable. There will be a follow up in 6 months.

#6060 - Tech Review: PUD for the building at 604-06 State Street was approved. The Rugby facility on Smith Road is asking for variances. No resolution. The owner of 921 Singer the owner is asking for a variance on street access. No resolution.

#6061 - Tier Two and Form R Reports: Reports were received from Seneca and Oxbow.

#6076 - Midwest Generation: Has been sold but will continue to operate.

#6078 - Alternative Energy Ordinances: The Village is creating a 2030 Comprehensive Plan, which has a section of Alternative Energy. The Village has minimal alternative energy ordinances. Ordinances continued to be collected from surrounding municipalities as they become available.

#6088 - Air quality non-attainment: The certification for non-attainment was requested and it is awaiting a decision from the USEPA. There is no word on the status of this item.

#6091 - Prairie Landscaping for residences - there is discussion around allowing residents to do native planting in residential areas. We will look forward to further information on this and encourage in whatever way we can.

#6093 - Sustainable House. Construction has been completed. The property has been purchased by a private citizen. The television continues to run and missed episodes can be found on the Carpenters Union website.

#6094 - Argonne Roundtable. No date set for the next roundtable

#6096 - CITGO: Turnaround still in progress.

#6097 - Recycle Day is April 12, 2014. All partners have responded with the exception of Waste Managements. Public Works will again be open.

#6098 - Brownfields-There is no information on the list of Brownfields.

#6099 - Each commissioner must complete the OMA computer training and provide HR with the certificate. Some of our commissioners have not yet completed the OMA training but will soon.

#6100 - Phillips 66 closed at 127^{th} and State. The site has an open LUST incident that should be considered by the Village during redevelopment. There will be a request for a FOIA from the IEPA.

#6101 - Village of Lemont/LEAC will plant trees the last week of April.

#6102 - Waste Management contract: There is no new information.

#6103 - Old Canal Restoration: A new business is moving into the end unit behind Stonehouse. This facilitated a discussion of canal restoration
