#6054 - Lemont Green Initiatives: Retain

**#6056** - Oxbow Midwest Calcining: Nothing to report. They experienced an improper procedure and the various agencies and lawyers are involved.

#6057 - Environmental Checklists: Discussion differed. They will be reviewed by each member and finalized at April meeting. It will then be sent to Charity Jones.

#6060 - Tech Review: No new items were submitted.

#6061 - Tier Two and Form R Reports: B. Reinke reports as they become available.

#6076 - Midwest Generation: The parent company is evaluating and closing plants as it deems appropriate.

**#6078** - Alternative Energy Ordinances: The Village has minimal ordinances. Ordinances continued to be collected from surrounding municipalities as they become available.

**#6088** - Air quality non-attainment: The certification for non-attainment was requested and it is awaiting a decision from the USEPA. There is no word on the status of this item.
