#6056 - Oxbow Midwest Calcining (formerly Chicago Carbon Company): See attached letter regarding emergency shutdown. All systems worked as they should.

**#6057** - Environmental Checklists: Charity Jones has assured the commission all things on the environmental checklist are covered in the ordinances. The commission will do a gap analysis.

#6060 - Tech Review: No new information on the PNC bank proposal.

The village purchased some property at the corner of Rt. 83 and Main St. There was no information available regarding environmental reports done by the village prior to this purchase. The commission is requesting some insight as to what environmental due diligence the Village had done, how the purchase was approved, involvement of various environmental agencies, etc.

Under the pending consent order, the MWRD will distribute 15,000 rain barrels within their service area at no charge.

**#6091** - Prairie Landscaping for residences-there is current discussion around allowing residents to do native planting in residential areas. We will look forward to further information on this and encourage in whatever way we can.
