#6057 - Environmental Checklists: E Carusiello reviewed the response from C Jones. Based on this E. Carusiello revamped the checklist particularly for industrial and light industrial. This new checklist is intended to aid the Village. The checklist will be reviewed by C. Albrecht, B. Rienke and T. Thomas. There will be a follow up discussion at the next meeting.

#6060 - Tech Review: No new items were submitted. C. Albrecht did meet with B. Wehmeier to review the documents for the purchase of the land at the corner Rt. 83 and Main Street. The discussion will continue.
