#6054 - Lemont Green Initiatives: Retain

**#6056 -** Oxbow Midwest Calcining: They have stabilized their operation. The EPA and IPCB are reviewing for possible penalties.

**#6057** - Environmental Checklists: The checklists have been reviewed. E Carusiello will be resending out the check lists to appropriate commissioners and will send the cover letter to all.

#6060 - Tech Review: No new items were submitted.

#6061 - Tier Two and Form R Reports: B. Reinke reports as they become available.

#6076 - Midwest Generation: Has closed two Chicago coal burning units and may consider the Joliet unit as well. Romeoville unit is not under any plan for plant closure.

**#6078** - Alternative Energy Ordinances: The Village has minimal ordinances. Ordinances continued to be collected from surrounding municipalities as they become available.

**#6088** - Air quality non-attainment: The certification for non-attainment was requested and it is awaiting a decision form the USEPA. There is no new word on the status of this item.

#6090 - Rain Barrel program: No new information. Still monitoring.
