#6060 - Tech Review: No pending submittals. Retain.

#6061 - Tier Two and Form R Reports: B. Reinke reports as they become available.

#6076 - Midwest Generation: the visit by the commissioners is pending. The shut down of the two oldest units was completed December 2010.

#6078 - Alternative Energy Ordinances: There are now advertisements on the radio and television for alternative energy sources for residential dwellings. This is going to cause some confusion and experimentation for homeowners.

#6083 – April 16, 2011 was the Spring 2011 recycling day. Good turn out despite the weather and again, good response from attendees. The results of the recycling activities are as follows:

 - o 3 containers (150 lbs.) batteries
 - No information on shredding
 - o 16,587lbs. electronic recycling
 - o 60 cars, 388 containers for paint collection
 - o 1,500 gallons of oil, 200 gallons of antifreeze and $\frac{1}{2}$ barrel of flammables collected by Citgo
