#6054 - Lemont Green Initiatives: Retain

#6056 - Oxbow Midwest Calcining (formerly Chicago Carbon Company) Commission met with Brett Wilshire and Robert Missan on Saturday, September. 17, 2011. It was an informative presentation and tour of the facility. This plant produces specialty materials and their process is well defined. The commission does not see that changing. T. Ballard has visited them several times with the same results. That is their process.

#6057 - Environmental Checklists: Charity Jones will be asked to cross-reference the checklist with the ordinances. The Commission will then review the results.

#6060 - Tech Review: Nothing to report.

#6061 - Tier Two and Form R Reports: B. Reinke reports as they become available.

**#6078** - Alternative Energy Ordinances: The Village has minimal ordinances. Ordinances continued to be collected from surrounding municipalities. The commission will continue to research this topic.

#6083 – Recycling: The Fall date is set for October 15<sup>th</sup>, 2011, from 9AM-1PM, and will include all previous activities except tree planting and bicycle collection. Things are in place and we look forward to a successful event.

#6084 – Items to put on our agenda for the coming year

- Rain Barrel program contact Will County or others to research this project. The Metropolitan Water Reclamation District (MWRD) might be an option. The current price from MWRD is \$51. T. Thomas will check the prices at the local big box stores for comparison purposes.
- Prairie Landscaping for residences-there is current discussion around allowing residents to do native planting in residential areas. We will look forward to further information on this and encourage in whatever way we can.
